THESE CONCEPTS INCLUDE THE STUDY OF BIO-CLIMATIC ARCHITECTURAL ENVIRONMENT STRUCTURAL DESIGN AND INNOVATIVE CONSTRUCTION TECHNIQUES. DURING THE YEAR, 71 PARTICIPANTS, FROM AROUND THE WORLD, ATTENDED NINE, FIVE WEEK LONG WORKSHOPS AT ARCOSANTI WHERE THEY INSTALLED A GREY WATER SYSTEM. ALSO, OVER 200 COLLEGE STUDENTS ATENDED VARIOUS EDUCATIONAL PROGRAMS AT ARCOSANTI. 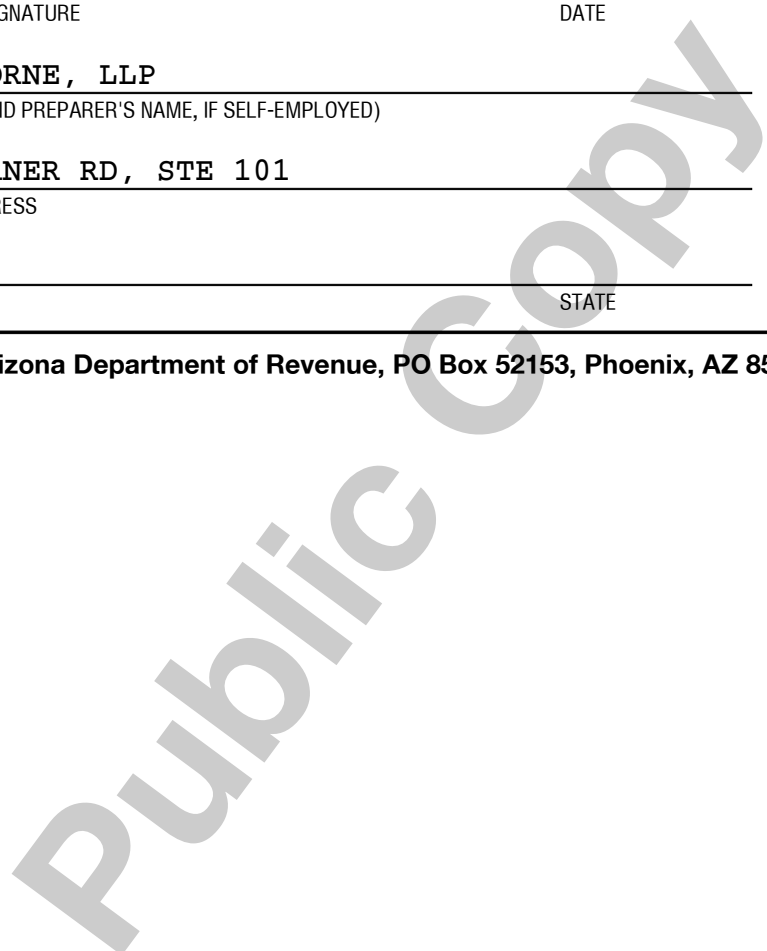
